(b) a hospital, medical, educational or research institution or a registered medical practitioner for the purpose of supply to his patients, or

(c) a manufacturer of hydrogenated vegetable oils, beverages, confectionaries and other non-medicinal products, where such drugs are required for processing these products;

6. The licensee shall inform the Licensing Authority in writing in the event of any change in the constitution of the firm operating under the licence.
